NOW, THEREFORE, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to Gargi Shikshak Prashikshan Mahavidyalaya, VPO – Budhwal, Tehsil – Behror, Alwar – 301709, Rajasthan for conducting B.Ed. Course of Secondary (level) of one year duration an annual of 100 (Hundred Only) students from the academic session 2008-09 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the **Northern** Regional Committee.

 The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
